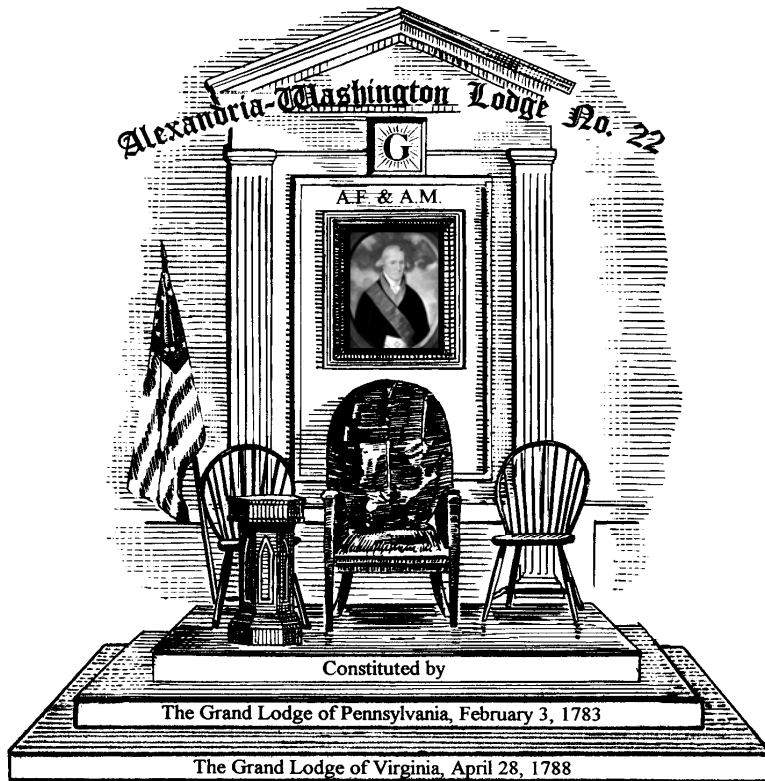

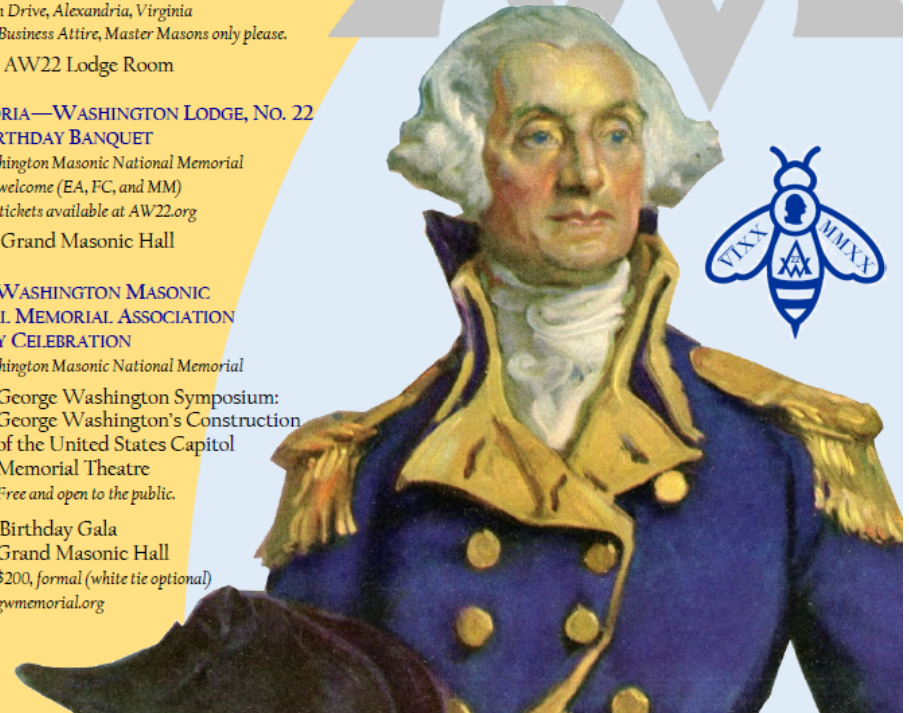

# Alexandria-Washington Lodge, No. 22, Foundation

Last year the Lodge began exploring a fundraising campaign to support needed preservation projects for our collection of artifacts and to aesthetically update our physical space ahead of the centennial anniversary celebration activities in 2023. A preliminary plan was presented to the Lodge, but that plan was intentionally delayed as we continued our research. The plan sought to garner grant money, but, generally speaking, fraternal organizations (our tax designation under the Grand Lodge) cannot receive grant funds. In addition, contributions from individuals to a fraternal organization are not tax deductible.

We reached out to other Lodges in the region to see how they had overcome these obstacles. Universally, the answer was establishing a non-profit, 501(c)(3) foundation. A non-profit, 501(c)(3) foundation is a designated charitable enterprise. It is specifically designed to ensure that contributions go toward specific areas and that no one (person or organization) profits from the proceeds. It assures grant making foundations that their investment in our preservation and education efforts will indeed go to those ends. It also grants tax deductible status for contributions received.

The first step in establishing a foundation is writing a foundation charter. The process is currently underway and a charter board of directors has been selected. They will be announced when the charter is circulated to the Lodge prior to submission to the Commonwealth. Once the charter is ratified by the government, we will apply for non-profit 501(c)(3) status with the Internal Revenue Service. Both of these steps require diligence on our part and we are fortunate to have a number of brothers navigating confusing and bureaucratic mazes for us. When completed, we will begin fundraising efforts in earnest.

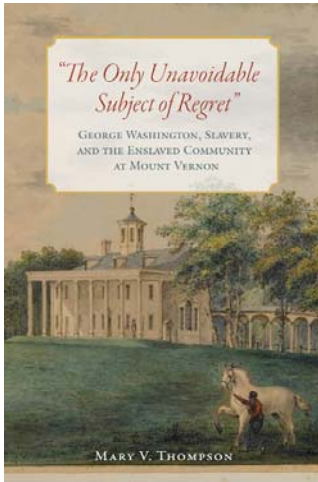
Here are some basic questions that we have had encountered along the way to give you a little clearer understanding:

- Aren't gifts to the lodge tax deductible? No, due to fraternity status.
- Will money be moved from the Lodge endowment? No, all funds in the foundation account will be raised for that purpose. The Lodge can contribute as they see fit by vote.
- Will the archives move to the foundation? No, the Trustees still maintain jurisdiction over all Lodge property.

The foundation will essentially be a financial clearing house to ensure we can optimize fundraising efforts to protect our collection and enhance our efforts to educate the Alexandria community and beyond.

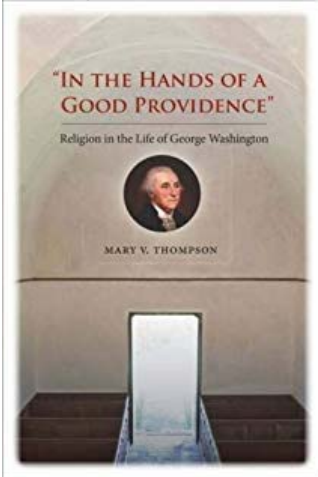
# Read up for March

Mary Thompson will speak at the March Stated Communication. Her books on George Washington and religion and George Washington and slavery are considered definitive for the topics. So, grab a book and read up before March!



George Washington's life has been scrutinized by historians over the past three centuries, but the day-to-day lives of Mount Vernon's enslaved workers, who left few written records but made up 90 percent of the estate's population, have been largely left out of the story. In "*The Only Unavoidable Subject of Regret*," Mary Thompson offers the first comprehensive account of those who served in bondage at Mount Vernon. Drawing on years of research in a wide range of sources, Thompson brings to life the lives of Washington's slaves while illuminating the radical change in his views on slavery and race wrought by the American Revolution.

Thompson begins with an examination of George and Martha Washington as slave owners. Culling from letters to financial ledgers, travel diaries kept by visitors and reminiscences of family members as well as of former slaves and neighbors, Thompson explores various facets of everyday life on the plantation ranging from work to domestic life, housing, foodways, private enterprise, and resistance. Along the way, she considers the relationship between Washington's military career and his style of plantation management and relates the many ways slaves rebelled against their condition. The book closes with Washington's attempts to reconcile being a slave owner with the changes in his thinking on slavery and race, ending in his decision to grant his slaves freedom in his will.



Attempts by evangelical Christians to claim Washington and other founders as their own, and scholars' ongoing attempts to contradict these claims, are nothing new. Mount Vernon researcher Mary Thompson endeavors to get beyond the current preoccupation with whether Washington and other founders were or were not evangelical Christians to ask what place religion had in their lives. Thompson follows Washington and his family over several generations, situating her inquiry in the context of new work on the place of religion in colonial and post-revolutionary Virginia and the Chesapeake.
